CEREMONY VENUE

At Bon Cap, we present two distinct on-site options for your ceremony: a tranquil garden setting and an air-conditioned chapel, providing an appealing alternative to town-based ceremonies.

The ceremony venue fee encompasses the provision of standard chairs or benches and a pulpit. However, please be aware that this fee does not cover any extra décor, flowers, arches, candles, music, or chair covers. These additional elements are subject to separate quotations.

RECEPTION VENUE

As a fully operational farm, Bon Cap proudly offers a one-of-a-kind Winelands function room, providing picturesque views of our serene dam set against a backdrop of breathtaking mountains. Our venue is climate-controlled, and it features spacious outdoor seating areas beneath the charming vines. Furthermore, we have a splendid bar area with a grand fireplace, perfect for winter weddings.

INCLUDES

The venue hire encompasses a range of amenities, including the reception venue itself, a fully equipped licensed bar, tables, chairs, standard silver cutlery (with the option of gold cutlery available for a minimal cost), a selection of crockery, glassware, an extensive array of table linen, table runners, and napkins.

EXCLUDES

It's essential to note that the venue hire does not cover the costs associated with décor, styling, flowers, personalized gifting, a DJ, photographer, marriage officer, catering, beverages, accommodations, a diesel surcharge in case of power outages, or any specialized rental or hired items.



GENERATOR POWER FACILITIES

Notably, our venue and accommodations are equipped with full generator support to mitigate any potential power failures. In such instances, a diesel surcharge will be applicable and calculated based on the prevailing diesel fee at the time of the event, with estimates at R600 per hour.

FLOWER AND DÉCOR STYLING

At Bon Cap, we take pride in managing flower and décor styling in-house. To ensure your vision is realized, we will prepare a mock-up table layout during our initial bridal meeting, tailored to your preferences. It is crucial for us to have a clear understanding of your needs, ideas, and budget ahead of our first planning session. Should you prefer to engage your own florist or stylist, please be aware that terms and conditions will apply.

Furthermore, we kindly request that only biodegradable confetti are used outside the chapel. Please note that sparklers and glitter poppers are not permitted at Bon Cap.



LAPA HIRE

Our Lapa, located in the pool area, can be booked for an additional daily fee. It provides an ideal means of extending your wedding day with your guests. The fee includes the provision of wood, ice, cutlery, crockery, glassware, BBQ utensils, and a cleaning service.

You have the flexibility to either supply your own food and beverages or place an order through us. However, please keep in mind that the Lapa can only be reserved if accommodations are booked by your wedding guests. Additionally, out of consideration for the guests staying at Bon Cap, we do not permit music at the Lapa.

CATERING

At Bon Cap, we understand that the quality of food and the level of service are of paramount importance for any wedding. Therefore, please be advised that we do not permit external caterers on the wedding day.

We do not offer standardized menu selections at Bon Cap. Instead, we encourage our couples to create a customized menu that aligns with their specific preferences, and we are more than willing to provide suggestions to accommodate your needs.

In terms of budget, our estimates typically range from R500 to R600 or higher per person, depending on the specific requirements of your event. Our quotes and menus are meticulously crafted to meet the unique demands of each couple. This encompasses a wide range of options, including breakfast, brunch, lunch, dinner, picnics, as well as a choice between plated and buffet-style service. Multiple courses and the option for food and wine pairings are also available.

It's crucial to bear in mind that menu planning is influenced by the seasonal availability of ingredients. Additionally, a 10% service fee is applied to the catering cost on the wedding day, designated as a "staff fee." Please note that the catering cost does not cover wine, beverages, or coffee stations.

SPECIAL REQUIREMENTS

At Bon Cap, we are dedicated to accommodating various dietary requirements, including those for vegans, vegetarians, individuals with gluten intolerance, and Halaal preferences.

Please note that while we are happy to assist with Halaal requirements, our kitchen is not Halaal certified, and special Halaal meals are ordered from a certified Halaal kitchen.

Regarding catering quotes, during our initial planning session, we base them on the estimated number of guests attending. However, these quotations will be finalized three months prior to the wedding to account for potential fluctuations in food prices. We strive to make every effort to stay within your specified budget.

In terms of guest count, if there is a 10% decrease from the original count stated during the first planning meeting, this will result in a 10% increase in the catering cost. The final guest count for billing purposes is due 14 days before the reception.

WINE AND BEVERAGES

Bon Cap is a fully licensed venue, and couples have the option to provide us with a wish list to enhance our bar offerings, tailoring it to their guests' preferences. We offer a comprehensive bar service, whether on a cash basis or subsidized, which includes bar staff, glassware, ice, and more, all at no additional cost. However, please note that waiter service is not included in this offering.

It's important to be aware that wine and beverage prices are subject to change. Additionally, the bar service operates within specific hours, closing promptly at 15h45 for midday events and 23h45 for evening events.

If you choose to bring your own wines, there is a cork fee of R50 per bottle for self-supplied wines.

PAYMENT SCHEDULES

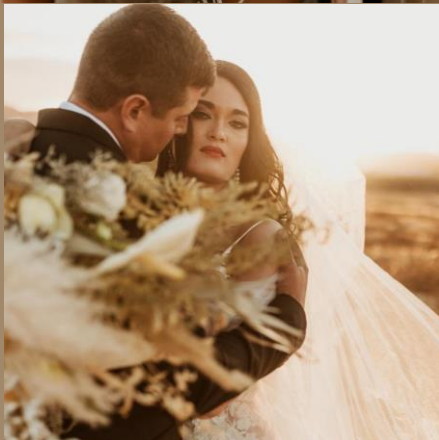
To facilitate your wedding preparations, we have established the following payment schedule:

- The retainer fee + refundable breakage deposit to secure the wedding date
- 50% of the total cost is payable 5 months prior to the wedding.
- An additional 40% of the total cost is due 1 month prior to the wedding.
- The remaining 10% and any outstanding costs must be settled on the day of the event.

Please be aware that Bon Cap reserves the right to cancel bookings if payments are not made within the specified timeframes. In the interest of clarity, all additional expenses incurred must be paid in full before departure.

Please note that inquiries or concerns related to a specific invoice will not serve as a valid reason for withholding payment on any other invoice.

CANCELATION POLICY

When booking the venue at Bon Cap, it is essential to acknowledge and agree to settle any penalties or cancellation fees associated with food, beverages, and accommodation, which may be imposed in the case of a total cancellation. - The retainer fee, paid to secure the date, is non-refundable.
- The amount charged for the total cancellation of the event will be determined based on factors such as the timeframe and flexibility for Bon Cap to secure another booking for the event that was cancelled.

Additionally, a post-wedding breakfast is typically served between 09h00 and 10h00. Please keep these timings in mind when planning your event at our venue.

PRICE / COST
